



## HEALTH CARE NEEDS POLICY

### **Purpose**

To ensure that Willow Grove Primary School provides appropriate support to students with health care needs.

### **Objective**

To explain to Willow Grove Primary School parents, carers, staff and students the processes and procedures in place to support students with health care needs at school.

### **Scope**

This policy applies to:

- all staff, including casual relief staff and volunteers
- all students who have been diagnosed with a health care need that may require support, monitoring or medication at school.

### **Policy**

This policy should be read with Willow Grove Primary School's *First Aid and Medications, Anaphylaxis* and *Asthma* policies.

At Willow Grove Primary School if a student is *diagnosed with Asthma, or an Allergy, or Anaphylaxis only*, a Student Health Support Plan is not required. Where a student diagnosed with Asthma, or Allergies, or Anaphylaxis enrolls at our school the parent/carer must provide the school with the appropriate Action Plan which has been completed by the student's medical practitioner. Please refer to the students Asthma, Allergic Reaction, or Anaphylaxis Action Plan for medication and emergency treatment. Willow Grove Primary School's Asthma and Anaphylaxis policies also deal with our schools processes and procedures in place to support students diagnosed with Asthma or Anaphylaxis.

### **Student health support planning**

In order to provide appropriate support to students at Willow Grove Primary School who may need medical care or assistance, a Student Health Support Plan will be prepared by the student's classroom teacher and/or the principal in consultation with the student, their parents, carers and treating medical practitioners (except Asthma, Allergy or Anaphylaxis as outlined above).



Student Health Support plans help our school to assist students with:

- routine health care support needs, such as supervision or provision of medication
- personal care support needs, such as assistance with personal hygiene, continence care, eating and drinking, transfers and positioning, and use of health-related equipment
- emergency care needs, such as predictable emergency first aid associated with seizure or diabetes management.

Students with complex medical care needs, for example, tracheostomy care, seizure management or tube feeding, must have a Student Health Support Plan which provides for appropriate staff to undertake specific training to meet the student's particular needs.

At enrolment or when a health care need is identified, parents/carers should provide accurate information about the student's condition or health care needs, ideally documented by the student's treating medical/health care practitioner on a Medical Advice Form (or relevant equivalent) Note: Template health planning forms are available here: <https://www2.education.vic.gov.au/pal/health-care-needs/resources>

Willow Grove Primary School may invite parents and carers to attend a Student Support Group meeting to discuss the contents of a student's Health Support Plan and assistance that the student may need at school or during school activities.

Where necessary, Willow Grove Primary School may also request consent from parents and carers to consult with a student's medical practitioners, to assist in preparing the plan and ensure that appropriate staff understand the student's needs. Consultation with the student's medical practitioner will not occur without parent/carer consent unless required or authorised by law.

Student Health Support Plans will be reviewed:

- when updated information is received from the student's medical practitioner
- when the school, student or parents and carers have concerns with the support being provided to the student
- if there are changes to the support being provided to the student

### **Management of confidential medical information**

Confidential medical information provided to Willow Grove Primary School to support a student will be:

- recorded on the student's file
- shared with all relevant staff so that they are able to properly support students diagnosed with medical conditions and respond appropriately if necessary.
